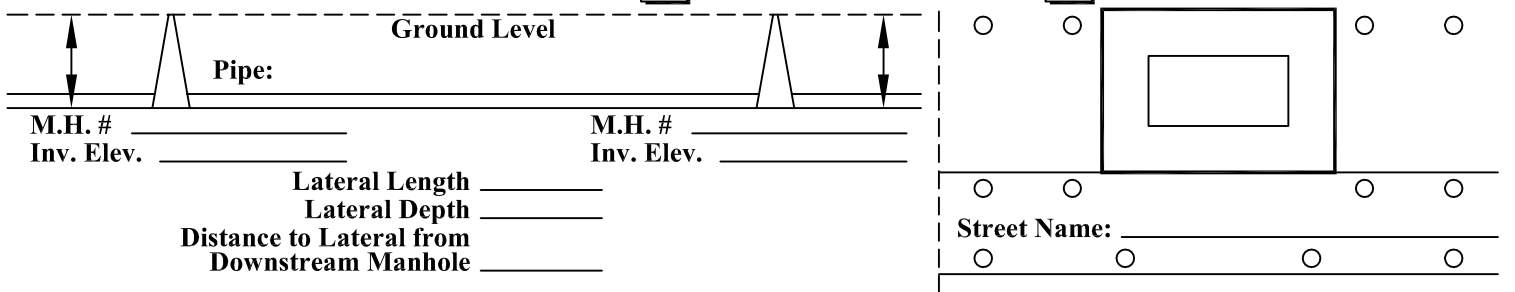

**The Permittee, by payment of the fee, acknowledges and accepts the following conditions:**

- 1.) The Municipal Authority must be given immediate notice of any change in ownership of the property.
- 2.) The Permittee has verified that the proposed building will be constructed TO SUIT EXISTING SEWER LINE ELEVATION at an elevation that will enable it's sanitary sewer to drain into Authority's sewer BY GRAVITY:  YES
- 3.) Or is proposing to install a sanitary sewer pump to lift the sewage from this proposed building to the location on the main line as selected by the Authority. BY PUMP:  YES
- 4.) Schedule 40 pipe will be used and the installation will include all the fittings shown on the Detail Drawing.
- 5.) The Municipal Authority will be given 24 HOURS notice to schedule installation of saddle connection to the Main Line.
- 6.) The Municipal Authority will be given 48 HOURS notice as required by the Tapping Permit to schedule inspections.
- 7.) The OWNER of the proposed building has fully executed a COMMERCIAL TAP AGREEMENT.  YES
- 8.) If the premises is located within the Brush Creek Drainage Area, permittee is required to make application to the Western Westmoreland Municipal Authority for a separate capacity tapping fee and to pay any applicable tapping fee.
- 9.) The below noted special conditions will be complied with as required:

Permittee grants to the Authority future access to the Premises at any reasonable time, upon receiving reasonable prior notice of same, for the purpose of inspecting and/or testing the Premises for any illegal connections, and agrees that said consent is binding on the heirs, transferees and/or assignees of the Permittee.
- 11.) Permittee, and the heirs, transferees, and/or assigns of same, agrees to be bound, while receiving sanitary sewer services from the Authority, by the Rules and Regulations of the Authority, as amended.
