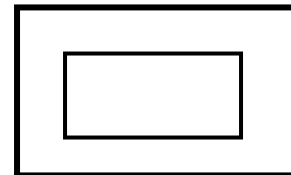

The Permittee, by payment of the fee, acknowledges and accepts the following conditions:

1. NHTMA must be given immediate notice of any change in ownership of the property.
2. The Permittee has verified that the proposed building will be constructed at an elevation that will enable its sanitary sewer to drain into NHTMA sewer; or
3. Is proposing to install a sanitary sewer pump to lift the sewage from this proposed building to the location on the main line as selected by NHTMA.
4. Schedule 40 or SDR 35 pipe will be used, and the installation will include all the fittings shown on the specifications.
5. NHTMA will be given 24 hours' notice to schedule installation of saddle connection to the main line.
6. NHTMA will be given 24 hours' notice to schedule inspections.
7. If the premises is located within the Brush Creek Drainage Area, permittee is required to make application to the Western Westmoreland Municipal Authority for a separate capacity tapping fee and to pay any applicable tapping fee. NHTMA will not issue a permit without a WWMA permit.
8. Permittee grants for NHTMA future access to the premises at any reasonable time, upon receiving, reasonable prior notice of same, for the purpose of inspecting and/or testing the premises for any illegal connections, and agrees that said consent is binding on the heirs, transferees and/or assignees of the Permittee.
9. Permittee, and the heirs, transferees, and/or assigns of same, agrees to be bound, while receiving sanitary sewer services from NHTMA, by the Rules and Regulations of NHTMA, as amended.
10. The below noted special conditions will be complied with as required:
